BOROUGH OF SUSSEX COUNTY OF SUSSEX ORDINANCE NO. 2024-13

AN ORDINANCE AMENDING SUBSECTION 24-1.1, ENTITLED "MUNICIPAL CLERK", OF SECTION 24-1, ENTITLED "APPLICATIONS FOR LICENSES, PERMITS, OR APPROVAL", OF CHAPTER 24, ENTITLED "FEES" and SECTION 10-5, ENTITLED "ISSUANCE OF PERMITS" OF CHAPTER 10, ENTITLED "MUNICIPAL PARKING LOTS", OF THE CODE OF THE BOROUGH OF SUSSEX, COUNTY OF SUSSEX AND STATE OF NEW JERSEY.

BE IT ORDAINED by the Borough Council of the Borough of Sussex, in the County of Sussex and State of New Jersey, as follows:

SECTION 1. Paragraph (b), entitled "Licenses/Permits" of Subsection 24-1.1, entitled "Municipal Clerk", of Section 24-1, entitled "Applications for Licenses, Permits, or Approvals" of "Chapter 24, entitled "Fees", be and is hereby amended to replace the portion under the heading "Parking" which reads:

Harrison Street/Mill Street/Spring Street Lots

\$40.00 per month

with:

Harrison Street/Mill Street/Walling Ave Lots

\$40.00 per month

SECTION 2. Paragraph (c) of Section 10-5, entitled "Issuance of Permits", of Chapter 10, entitled "Municipal Parking Lots" be and is hereby amended to read as follows:

c. The fee for each parking space shall be \$40 per month or \$480 per year if an annual permit

is purchased.

SECTION 3. If any article, section, subsection, paragraph, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect.

SECTION 4. In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the Borough, the provisions hereof shall be determined to govern. All other ordinances of the Borough are hereby ratified and confirmed, except where inconsistent with the terms hereof.

SECTION 5. This Ordinance shall take effect immediately upon final passage and publication according to law.
