

**BOROUGH OF SUSSEX

ORDINANCE NO. 2024-25**

**AN ORDINANCE TO AMEND SECTION 2-14, ENTITLED
“COMMUNITY AND CULTURAL EVENTS ADVISORY COMMITTEE”
OF CHAPTER 2, ENTITLED “ADMINISTRATION” OF THE CODE OF
THE BOROUGH OF SUSSEX.**

BE IT ORDAINED by the Borough Council of the Borough of Sussex, in the County of Sussex and State of New Jersey, as follows:

SECTION 1. Section 2-14, entitled “Community and Cultural Events Advisory Committee” of Chapter 2, entitled “Administration” of the Code of the Borough of Sussex, Sussex County, New Jersey is hereby renamed “Community Events Committee”.

SECTION 2. Subsection 2-14.1, entitled “Establishment” of Section 2-14, entitled “Community and Cultural Events Advisory Committee” of Chapter 2, entitled “Administration” of the Code of the Borough of Sussex, Sussex County, New Jersey is hereby amended to read as follows:

§ 2-14.1. Establishment.

There is hereby established the Community Events Committee of the Borough of Sussex which shall serve in accordance with the provisions of this section.

SECTION 3. If any article, section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect.

SECTION 4. In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the Borough, the provisions hereof shall be determined to govern. All other ordinances of the Borough are hereby ratified and confirmed, except where inconsistent with the terms hereof.

SECTION 5. This Ordinance shall take effect immediately upon final passage and publication according to law.
